<u>Hunt rules</u> – Hunter safety and welf	are requires that all hunter	s obey all instructions from the outfitter
during the hunt and while using the	lodge, hunting properties,	stands, equipment and vehicles. The

hunter and outfitter will comply with all federal, state and local laws and regulations applicable to the

hunt. The outfitter's interpretation and application of such laws and regulations and direction regarding any issues related to a safe and ethical hunt is final. In particular, the hunter will wear a safety harness whenever hunting from any elevated position and will only take shots, whether using a bow or a firearm, that the hunter has practiced before the hunt and believes he or she is competent to execute both safely and ethically. Further, the use of alcoholic beverages or drugs (including prescription drugs) can impair the hunter's ability to hunt safely and ethically. The outfitter's personal judgment in the event such impairment is apparent or even possible is final and can result in the hunt being terminated without refund. The hunting lodge, hunting properties, stands, equipment and vehicles are shared space and common ground for all hunters participating during the same period. Inappropriate or discourteous behavior, even if not directed at another hunter, and any behavior tending to make the hunt unsafe or unethical will result in expulsion from the lodge and termination of the hunt without refund. Hunters who are minors may participate in the hunt only with the written consent of their parent or guardian and must be within the control of an adult hunter at all times and must comply with all laws applicable to minors, including laws related to consumption of alcoholic beverages. Monarch Rivers makes every effort to manage the deer resources available on every hunting property so as to provide the best opportunity for every hunter to see and kill big bucks. The hunter agrees to use his or her best efforts to kill only mature does and bucks aged at least 4½ years with antlers scoring 130 under the SCI standard. The hunter further agrees that hunt-related pictures of the hunter and any minors for whom the hunter is that person's parent or guardian may be published, including being posted on the Internet, to promote Monarch Rivers.

Liability understanding and release — The hunter understands and accepts that the hunt he or she is asking Monarch Rivers to provide, including transportation and accommodations, includes inherent risks of serious personal injury or death and significant property damage that cannot be eliminated or significantly mitigated even with the exercise of all reasonable safety training, precautions, and equipment. The hunter accepts personal responsibility for those risks and agrees to release completely and permanently the outfitter (Aaron Quillan), Monarch Rivers LLC, all persons involved in providing or participating in the hunt, and any owners of land where the hunt occurs from any legal or financial liability for injury, death or damages that occur during or because of the hunt, even injury, death or damage caused by the negligence of those persons. Further, the hunter wishes to protect those persons identified above from the threat and expense of lawsuits related to such personal injury, death or property damage and, therefore, also agrees to indemnify those persons identified above from costs and any legal judgment that might arise from such lawsuits filed on behalf of the hunter. The hunter also agrees to provide to those persons identified above the same release and indemnification on behalf of any person participating in the hunt who is a minor and to whom the hunter is that person's parent or guardian.

minor will be within the control of an adult hunter at all times during the hunt.
